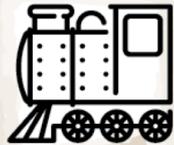

Introduction to Creative Commons Licenses

- The Creative Commons copyright licenses allows for some flexibility and granting of permission within the traditional “all rights reserved” setting that copyright law creates.
- Creative Commons tools give everyone from individual creators to large companies and institutions a simple, standardized way to grant copyright permissions to their creative work.
- Through their unique tools and licensing, and the users who apply them to their work, Creative Commons has overseen the growth of a digital commons - a pool of content that can be copied, distributed, edited, remixed, and built upon, all within the boundaries of copyright law.

What Creative Commons License do

- All Creative Commons licenses have many important features in common.
- Every license helps creators retain copyright while allowing others to copy, distribute, and make some uses of their work — at least non-commercially.
- Every Creative Commons license also ensures creators get the credit for their work they deserve.
- Every Creative Commons license works around the lasts as long as applicable copyright lasts (because they are built on copyright).
- These common features serve as the baseline, on top of which creators can choose to grant additional permissions when deciding how they want their work to be used.

Creative Commons Licenses



■ Attribution

■ CC BY

- This license lets others distribute, remix, tweak, and build upon your work, even commercially, as long as they credit you for the original creation.
- This is the most accommodating of licenses offered.
- Recommended for maximum dissemination and use of licensed materials.

Creative Commons Licenses



■ Attribution-ShareAlike

■ CC BY-SA

- This license lets others remix, tweak, and build upon your work even for commercial purposes, as long as they credit you and license their new creations under the identical terms.
- This license is often compared to “copyleft” free and open source software licenses.
- All new works based on yours will carry the same license, so any derivatives will also allow commercial use.
- This is the license used by Wikipedia, and is recommended for materials that would benefit from incorporating content from Wikipedia and similarly licensed projects.

▣ Attribution-NoDerivs

▣ CC BY-ND

- This license lets others reuse the work for any purpose, including commercially...
- However, it cannot be shared with others in adapted form, and credit must be provided to you.

Creative Commons Licenses



- **Attribution-NonCommercial**
- **CC BY-NC**
 - This license lets others remix, tweak, and build upon your work non-commercially, and although their new works must also acknowledge you and be non-commercial, they don't have to license their derivative works on the same terms.

- **Attribution-NonCommercial-ShareAlike**
- **CC BY-NC-SA**
 - This license lets others remix, tweak, and build upon your work non-commercially, as long as they credit you and license their new creations under the identical terms.

Creative Commons Licenses



- **Attribution-NonCommercial-NoDerivs**
- **CC BY-NC-ND**
 - This license is the most restrictive of our six main licenses, only allowing others to download your works and share them with others as long as they credit you, but they can't change them in any way or use them commercially.

Creative Commons in the Public Domain

- Creative Commons also provides tools that work in the “all rights granted” space of the public domain.
 - Their CC0 tool allows creators to waive all rights and place a work in the public domain.
 - Their Public Domain Mark allows any web user to “mark” a work as being in the public domain.

- However, as our aim is to safeguard your oral history projects in the Public Domain, we would not recommend that you waive your rights, and the rights of your narrator, when publishing content online.

Creative Commons in the Public Domain

■ CC0 Agreement

- You can use this universal tool if you are a holder of copyright or database rights and you wish to waive all your interests, if any, in your work worldwide.
- This may be the case if you are reproducing an underlying work that is in the public domain and want to communicate that you claim no copyright in your digital copy where copyright law may grant protection.

Creative Commons in the Public Domain

▣ Public Domain Mark

- You can use this tool if you have identified a work that is free of known copyright restrictions.
- Creative Commons does not recommend this tool for works that are restricted by copyright laws in one or more jurisdictions.


Applying a Creative Commons License to your Oral History Project

- Usually to apply a Creative Commons License to work published online, it is typical to include it in the footer of a website or web page.
- However, if you are applying a Creative Commons License to your oral history project, you can do so in two ways:
 1. You can write a record an introduction to your Oral History project which outlines that you are using a Creative Commons License, and state which license you are applying.
 2. You can copy and paste the appropriate Commons License logo to the online repository, web page or social channel where you publish your Oral History project.
- It is also a good practice to link the icon to the relevant license deed, which you can access through the Creative Commons site: <https://creativecommons.org/licenses/>
